**47%**

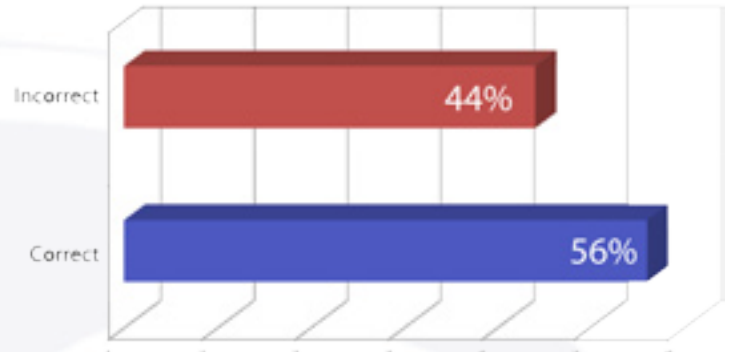
**Q5.** If someone says that they need your password to help you, should you give it to them?

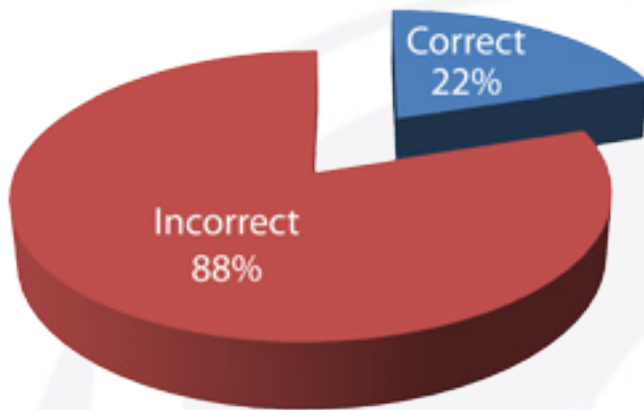
